- (2) Employability of youth by proper implementation of Government Schemes of skill development/skill India.
- (3) To change the syllabi of convensional Programme(s), like-B.A.,B.Sc,B.Com and so by including skill course(s) during a semester / 6th semester.
- (4) Use of knowledge and skill of youth for development of society, Nagaland State and the Nation. Ultimately, uprooting of poverty, evils and diseases is the goal which cannot be attained unless students are made to involve.

(5) M.O.U. with Industries like-Pharmaceutical Industries and Food Processing, related.

Hence, the affiliated colleges may take action on:

- (1) **Establishment of Training, Placement and Entrepreneurship Development Cell** in the college with an appointment/deputation/additional charge of a Placement Officer as per rules and regulations.
- (2) **Adoption of at least One Village** by each college for:
 - (i) Village Sanitation (ii) Drinking Water Arrangements (iii) Energy, Including Renewable Energy
 - (iv) Agriculture and Allied Activities (v) Improving Technology of Handicrafts.
 - (v) Health Awareness Programmes (vii) Skill Development Programmes at the village(s).
- (3) The Placement Officer of the College will be responsible for:
 - (i) Organizing Personality Development Programmes at the college (ii) Training Programmes of Students (iii) Placement Related Activities (iv) Introduction of Skill Related Programme(s)/Course(s) of State and Central Govt/U.G.C. Schemes (v) Interaction with Alumni Group of students of College/the University (vi) Awareness Programmes for Development and cure from diseases, like- AIDS.
