
All Heads and Representatives of the Department will present their requirement with a power point presentation before a committee on 18th November, 2022 at 11:00 AM in the Dean's office.


**MEETING MINUTES ON DEPARTMENT WISE SUB-ALLOCATION OF FUNDS UNDER




