MEETTING MINUTES OF THE COMMITTEE CONSTITUTED TO EXAMINE THE MEMORANDUM SUBMITTED BY NUTA-M AND NUNTS, NAGALAND UNIVERSITY, MEDZIPHEMA CAMPUS.

The meeting of the Committee constituted to examine the Memorandum submitted by NUTA-M and NUNTS, Medziphema Campus regarding enhancement of medical reimbursement amount under the purview of the Pro Vice-Chancellors and other medical related matters under Nagaland University was held on 29 November, 2018 at 11:00 a.m. in the Office Chamber of the Registrar, Nagaland University, Lumami.

At the outset, the Registrar welcomed all the members and thanked them for attending the meeting. The Registrar then read out the Memorandum submitted by NUTA-M and NUNTS, N.U, Medziphema Campus point-wise and the members discussed the matters threadbare.

The following agenda were discussed and resolved:

Agenda: 1: Enhancement of Medical Reimbursement under the purview of the PVC for each Campus.

Resolution: The Committee resolved to recommend enhancement of Medical Reimbursement under the purview of the PVC of each Campus from Rs.20,000/- to Rs. 40,000/-. This provision may be limited for treatment within the State of Nagaland.

Further, the Committee recommended that Medical treatments for outside the State, CS (MA) Rule and the directives of the UGC as applicable from time to time, may be followed. (Ref. UGC letter No.F.56-6/2012 (CU) dated March 2011).

Agenda:2: Empanelment of Hospitals:

Resolution: The Committee observed that the University is not competent to empanel Hospitals as per CS (MA) Rule. The Ministry of Health & Family welfare is the only competent authority to empanel Hospitals.

Agenda:3: University Medical Board with State Medical Representative:

Resolution: For medical treatment, only the Ministry of Health & Family Welfare is the competent authority to set up Medical Board. However, the Committee suggests to approach the Central Ministry of Health & Family Welfare to allow setting of in-house Medical Board under Nagaland University in the interest of its employees.

Agenda:4: Medical Advance:

Resolution: For sanctioning of medical advance, the Committee recommended that grant of advance may be accorded depending on the case as per CS(MA) Rules and on the basis of the advice of the treating Doctor / Nagaland University Medical Officer.

The meeting ended with vote of thanks from the chair.
