Sir(s)/Ma'am,

It is to inform you that Clause 28 of Schedule III of Legal Education Rules 2008, which deals with age restriction for taking admission in LL.B course was notified in the Gazette of India vide Part-III, Section 4, New Delhi on 21-27 March, 2009. As per Clause 28, upper age limit for admission in LL.B three year course was 30 years and for LL.B five year course was 20 years. The same was re-notified/restored by the circular No. BCI/D/1519/ (LE:Cir.-6) dated 17.09.2016 by Bar Council of India, in the light of Hon'ble Madras High Court order.

Thereafter, the above said circular No. 6 dated 17.09.2016 had been challenged before the Hon'ble Supreme Court of India in Writ Petition (Civil) No. 1023/2016 namely Rishabh Duggal & ANR. Vs. The Bar Council of India & ANR. Hon'ble Supreme Court of India on dated 3.3.2017 passed an interim order staying Bar Council of India notification i.e. BCI/D/1519/ (LE:Cir.-6) dated 17.09.2016 related to age of admission into 3 year and 5 year law courses.

Please find the copy of circular and interim order dated 3.3.2017 passed by Hon'ble Supreme Court of India in Writ Petition (Civil) No. 1023/2016 (copy enclosed).

In the light of interim Stay, institutions may take admission without any age restriction in LL.B courses.

It is to inform you that Clause 28 of Schedule III of Legal Education Rules 2008 which deals with age restriction for taking admission in LL,B course was notified in the Gazette of India vide Part-III, Section 4, New Delhi on 21-27 March, 2009. As per Clause 28, upper age limit for admission in LL.B three year course was 30 years and for LL.B five year course was 20 years. The relevant clause is given below:

Age on admission:

"(a) Subject to the condition stipulated by a University on this behalf and the high degree of professional commitment required, the maximum age for seeking admission into a stream of integrated Bachelor of law degree program, is limited to twenty years in case of general category of applicants and to twenty two years in case of applicants from SC, ST and other Backward communities.

(b) Subject to the condition stipulated by a University, and the general social condition of the applicants seeking legal education belatedly, the maximum age for seeking admission into a stream of Three Year Bachelor Degree Course in Law, is limited to thirty years with right of the University to give concession of five further years for the applicant belonging to SC or ST or any other Backward Community."

As per the decision of the Legal education Committee and Bar Council of India general communication to all the Universities in the country indicating the following Rule 7 of Legal Education 2008 of the Bar Council of India i.e. Rule relating to Minimum marks in qualifying examination for admission is being sent herewith. It may be further noted that Bar Council of India has further directed that any deviation of/from would not be condoned. Furthermore any repeated instances from the same university would lead to the Bar Council of India derecognizing the University from awarding the Law degrees and also decline the approval of affiliation of the concerned Centre of Legal Education/Department of Law of the University

The stipulated/concerned rule Legal Education 2008 is quoted herewith

7. Minimum marks in qualifying examination for admission

Bar Council of India may from time to time, stipulate the minimum percentage of marks not below 45% of the total marks in case of general category applicants and 40% of the total marks in case of SC and ST applicants, to be obtained for the qualifying examination, such as +2 Examination in case of Integrated Five Years' course or Degree course in any discipline for Three years' LL.B. course, for the purpose of applying for and getting admitted into a Law Degree Program of any recognized University in either of the streams.

Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission into an institution but only shall entitle the person concerned to fulfill other institutional criteria notified by the institution concerned or by the government concerned from time to time to apply for admission.

It is hereby also reminded to you that the College/University should also follow Rule-10 of Legal Education Rules 2008 which is quoted hereunder
