Regulation for Granting of Permanent Affiliation (Non-Professional) 2021

1. The College should have completed at least 5(five) years of satisfactory performance after getting temporary/provisional affiliation and attained the academic and administrative standards as prescribed by the University/UGC/Statutory Body concerned from time to time.
2. The College should have a duly constituted Council/Board of Governors, etc.
3. The College should be accredited by NAAC or any other statutory accreditation agency by State/Central Govt.
4. **Land, Building, Etc.,**
 - (i) Undisputed ownership and possession of land free from any or all encumbrances.
 - (ii) Proper Registered land documents in the name of the College/Society/Trust.
 - (iii) Building(s) with sufficient space(s) for Administrative, Academic, Curricular/Co-Curricular activities, etc, should be available.
 - (iv) Academic building sufficient to accommodate Principal, faculties, classroom/lecture/seminar rooms, library and laboratories with a minimum of 15 sq.ft. per student in lecture/seminar rooms, library and 20 sq.ft. per student in each of the laboratories.
 - (v) Adequate measures for safety, security, pollution control, etc.
 - (vi) Necessary laboratory equipments as prescribed by the University/Statutory/Regulatory body concerned, for subjects requiring laboratory facilities.
 - (vii) A multi-purpose complex/an auditorium and facilities for sports, canteen, health care, separate common rooms for men & women, separate common rooms as per the local requirements as decided by the University with appropriate infrastructure
 - (viii) A play field with a running track of 200 metres and facilities for games and sports and having sports material; provided that this may be relaxed to some extent in the case of City Colleges.
 - (ix) Provisions for differently abled students (divyang).
 - (x) Adequate civic facilities for essentials like water, electricity, ventilations, washrooms separately for ladies and gents, sewerage, etc. in conformity with the norms laid down by the Central/State PWD.
 - (xi) Lecture/Seminar rooms, laboratories, faculty rooms, rooms for administrative staff including principal, common rooms and other facilities with appropriate infrastructure.
5. **Administrative & Teaching.**
 - (i) Principal, all teaching and administrative staff should be appointed as per norms of the UGC/ University laid down from time to time.
 - (ii) All the teaching and administrative staff are appointed on permanent (appointed on regular basis, in case of Govt. College) on the UGC/Govt. scale of pay.
 - (iii) The College should have CPF/EPF/PPF for the teachers and administrative staff.

6. Requirement of Teaching Staff in each Department.

A. (Science)

- (i) For General : 4 nos.
(ii) For Honours : 5 nos.

B. (Other Streams)

- (i) For General Course/Programme : 3 nos.
(ii) For Honours Course/Programme : 4 nos.
(iii) English Honours : 5 nos.

7. Library

- (i) The College Library should have at least 5,000 books. There should be a minimum of 300 books for each of the elective subjects, 500 books of each honours subject and 600 for English. Besides, the College library should have at least one copy of a textbook for each group of 5 students and one copy of a general or reference book for each group of 10 students.
- (ii) The college should subscribe Journals (Academic and General), Newspaper (National- a minimum of 2 and Local minimum of 3).
- (iii) Library Staff: The College should have qualified Librarian and subordinate staff.
8. The College pass percentage for the immediate past 3 consecutive years should be 70% and above.
9. Enrolment should be 70% and above of the intake capacity (as prescribed by the University) during the immediate past 3 consecutive years .
10. Balance Sheet of last 3 years to be shown.
11. Updated Society Registration .

* The requisite fees for permanent affiliation/Fixed Deposit(Reserve Fund) in the name of the college shall be as prescribed by the letter NO.NU-CDC/GEN-13/2015-6573, dated 09/01/2019.
