1. As per University Ordinances OB-6/Para 17 ' Request for renewal of provisional affiliation shall be submitted to the Registrar/Director, C.D.C. on prescribed proforma, along with required fee, six month before the expiry of the period of provisional affiliation. If a college/institution does not apply for renewal within the period stipulated above, the affiliation granted shall stand terminated automatically on the expiry of the period of provisional affiliation'.
2. The Principals of Colleges under Nagaland University are requested to adhere to U.G.C. (Affiliation of Colleges by Universities) Regulation 2009.
3. As per U.G.C. (Affiliation of Colleges by Universities) (1 amendments) Regulations 2012, the eligibility criteria for permanent affiliation includes NAAC- accreditation.
4. The proposed college seeking affiliation, at the time of inspection by the University, shall satisfy the requirements in respect of any of them prescribed by the Statutory, Regulatory body concerned, whichever is higher.
5. If the College is private, as per U.G.C. Regulations 2009, an Undertaking (Para 3.2.3) and Bond (Para 3.4) is to be submitted at the time of application by the Registered Society/Trust of the College.


