## Revised Criteria for Provisional Affiliation of a New College/Institution

- ]. Sponsoring Authority: Whether Government aided or Un-aided/self financed.
- 12.
- **2** Registration (for Non-Government colleges/institutions): The Society/Trust should be a registered body under Registration of Societies Act 1860.
- **3**. **Governing Body**: The College should have Governing Body comprising of about 14 members from academicians, Politicians, public leaders, etc.
- **4**. **College Site & Building**: The College should have undisputed ownership and possession of land measuring not less than 2 Acres if it is located in Metropolitan cities and 5 Acres if it is located in other areas. In this regard, following documents are required:
  - (a) Registered Land documents in the name of the Society/College.
  - (b) Land Use Certificate from the competent authority designated by the Government concerned.
  - (c) Building Plan of the proposed college, prepared by an Architect.
  - (d) Earthquake Protection Certificate, Fire Safety Certificate, from the competent authority.
  - (e) Adequate civic facilities for essentials like-water, electricity, ventilations, toilets etc.
  - (f) Adequate measures for safety, security, pollution control etc.
- **5**. Administrative, Academic and other building with sufficient accommodation to meet the immediate academic and other space requirement as specified by the University concerned for each higher education, course/programme with adequate scope for future expansion in conformity with the prescribed by the UGC/Statutory/Regulatory Body concerned, taking care that all buildings constructed in the colleges are disabled friendly.
- 6. Class Room Facilities: Sufficient classrooms, adequate furniture. In addition, there should be common room for students, latrine, recreation room/play ground, etc.
- **%**. Location of the College/Institution: Conducive for Educational Institution.
- 8 No. of Students: Adequate number of students in each class.
- **9**. Library: The College should have at least 5,000 books in the Library. There should be 300 books for each paper. Further, Library should have at least a copy of textbook for each group of 5 students. There should be a study room attached to the Library for reference. A Librarian should be appointed for the Library.
- 10. Principal & Teaching Staff: Qualified Principal to be appointed. Adequate number of qualified teachers as required to be appointed as per UGC/NCTE/INC/MCI/BCI, etc. norms.
- 11. Staff room: Separate rooms for Principal, teaching staff and administrative staff, etc.
- 12. Teachers Pay & Allowances: At least UGC basic scale,\* should be paid.
- **13** CPF/EPF/PPF (for Non-Government Colleges/Institutions): The College should have CPF/EPF/PPF for regularized & Permanent teachers.

- 14. **Bond/Undertaking:** to be executed as per U.G.C. Regulations 2009, Para 3.4.1-14(for non-Government colleges/institutions).
- 15. **Recognition/Approval Letter:** To be obtained from the concerned Apex Body (for professional Colleges/Institutions).
- 16. **Reserved Fund (for Non-Government colleges/institutions)**: A fixed deposit of Rs. 15 lakhs for Professional colleges and Rs.10 lakhs for non-professional colleges in the name of the College for a period of 5 years.
- 17. \*Fees: for Provisional affiliation of a new College Rs. 20,000/-for Arts and Commerce, Rs. 25,000/- for Science and Rs. 35,000/ for professional course respectively.
