## **NOTIFICATION**

In pursuance of the office order issued by the Government of Nagaland, Home Department, Nagaland State Disaster Management Authority, vide No: NSDMA-ER-COVID19-301/2020(Pt-II)/5316 dated Kohima, 11<sup>th</sup> May 2021 regarding total lockdown imposed in the State of Nagaland to prevent and combat the surge of COVID-19, it is to notify as under:

- 1. All offices under Nagaland University shall remain suspended w.e.f. 14<sup>th</sup> May 2021 to 21<sup>st</sup> May 2021 except the following essential services:
  - i. Medical ii. Security iii. Transport iv. Electricity v. Water Supply
- During the lockdown period, all officers in the rank of Assistant Registrar and above shall constitute the core group to attend urgent and essential official matters. All other employees should be available on call.
- 3. All employees are directed to stay in their respective work places during the lockdown.
- 4. All faculty and non-teaching staff travelling from outside the State and from the districts of Dimapur and Kohima or coming from containment zones to other districts shall be quarantined for 14 days or get tested on Day 7. If tested negative, shall continue to be quarantined up to Day 10. Whereas, if the test result is positive, should immediately isolate and contact the respective Health Centres of the University.

This notification shall be reviewed subject to new directives from the Central/State Government.
