NOTIFICATION

In supersession to office notification vide No:NU/ADM/A-20/05(A)-390 dated 18.06.21 and in compliance with order issued by the Government of Nagaland, Home Department, NSDMA, Kohima vide order No: NSDMA-ER-COVID19-301/2020(Part-II)/5502 dated 30.06.2021, the existing lock down measures is extended for 10 (ten) more days up to 10th July 2021 with further relaxations and re-opening of activities and additional guidelines as annexed.

Therefore, in view of the relaxed guidelines, all offices under Nagaland University shall function with 50% of the total staff during this period or till further orders as under:

- i. The Pro-Vice Chancellors and Dean, SET shall regulate the roster for attendance of 50% staff strength on any working day for their respective campuses.
- ii. For the headquarters Lumami, all controlling officers are assigned to work out the roster for 50% attendance of staff in each section/cell with care to segregate staff as far as possible, according to locations/zones in order to avoid roster duty of staff from different locations/zones working on the same day.
- iii. Covid appropriate behaviour to be strictly followed by all the employees.


