NOTIFICATION

In pursuance of the office order issued by the Government of Nagaland, Home Department, Nagaland State Disaster Management Authority, vide No: NSDMA-ER-COVID19-301/2020(Pt-II)/5316 dated Kohima, 8th January 2022 and 31st January 2022 to contain the spread of COVID-19, it is to notify as under:

- 1. All faculties, staff and students coming from outside the State shall be required to submit COVID-19 negative test report to the Health Centre done through RT-PCR/True Nat/CBNAAT with the swab given for testing not earlier than 3 (three) days of the date of arrival.
- 2. All academic/social/cultural/sports related programmes shall be restricted and allowed upto 50% capacity or up to a maximum of 200 persons whereas cafes, gymnasiums and multi-purpose hall shall be allowed to operate up to 50% capacity only.
- 3. Students having symptoms shall avoid entering hostel and are advised to undergo medical check-up.

This notification shall be reviewed subject to new directives from the Central/State Government.
