

**In connection to the incident on 25<sup>th</sup> November 2024, Prof. Sarat Chandra Yeniseti, Deptt. of Zoology was placed under suspension and the same was ratified in the 67<sup>th</sup> Executive Council Meeting. A six member Preliminary Enquiry Committee was constituted wherein in its report the Committee found Prof. Sarat Chandra Yeniseti guilty. Thereafter, an Enquiry Officer was appointed as per CCS(CCA) Rules, 1965. The Enquiry Officer had submitted his findings proving all articles of charges and statement of imputations of misconduct/misbehavior against the Charged Officer.**





**The sequence of actions taken by Nagaland University, along with the Enquiry Officer's Report, is placed for decision.**

**Discussion** The Executive Council Members deliberated on the case thoroughly and Examined the Enquiry Officer's report and all other materials on record. Basing on the report, evidences and considering the Past Service records of Charged Officer, the Executive Council found the Officer guilty of the charges and deemed it as a fit case to impose Major Penalty on Charged Officer as per Section 11(Penalties) (vii, viii, ix) of Central Civil Service (Classification, Control & Appeal) Rules 1965. The following three Major Penalty options available under the Rules were considered:

- I. Compulsory Retirement with admissible benefits.
- II. Removal from service which shall not be a disqualification for future employment under the government.
- III. Dismissal from service which shall ordinarily be a disqualification for future employment under the government.

**Resolution** After due deliberation and considering the nature and gravity of misconduct, the Members felt that, it is undesirable and no longer tenable to retain the service of **Prof. Sarat Chandra Yeniseti** in the University for his misconduct and resolved the following:

1. The Report of Enquiry Officer proving all articles of charges is accepted.
2. The Executive Council vide Statute 28 (2) of Nagaland University resolved to impose Major Penalty by awarding "Compulsory Retirement with Admissible benefits" with effect from the date of suspension i.e. 26<sup>th</sup> November 2024.
