2. Entrance test will be held at the Department of Law, Lumami, Nagaland University on the following days:


Written Test : 25th of July, 11:00 a.m

3. Syllabus for written Test (100 Marks) : Research Methodology and Current Legal Issues. For the interview/viva-voce, candidates must be prepared with power-point presentation on research interest/area.. Medium of entrance test will be in English only.
4. Selection of candidates will be purely on the basis of merit. Preference will be given to NET- JRF qualified candidates. The candidates must score 50% and above in the tests to be considered for selection.
5. Candidates must bring all original documents (from HSLC to LL.M, JRF-NET if any) and other certificates for scrutiny and also submit photocopies of the same on the day of interview. If any discrepancies is detected their candidature will be liable to disqualification.
6. The department reserves the right to fill up or not the full vacancies available and the discretion to reject any candidates without assigning any reasons.
