The technical specifications of required DG Sets are enclosed with this quotation form at Annexure 'B'. Quotations are advised to quote their Rate after careful study of the quotation's technical specifications as well as the following terms and conditions:-

- 1. Separate envelope should be used for Technical Bid as well as for Price Bid. The word "TECHNICAL BID/PRICE BID for DG Sets shall be prominently marked on the top of envelope and both these sealed envelopes (Technical Bid and Price bid) should further be put in a bigger envelop duly sealed and super scribed properly.

 Quotation envelop(s) must be sealed and super scribed "QUOTATION FOR DIESEL GENERATOR SETS" which shall be addressed to TheRegistrar, Nagaland University, Lumami-798627, Zunheboto, Nagaland.
- 2. The quotations should reach this office by **01:00 PM on 30th Nov. 2023 a**s per quotation notice. In case the office is closed on this date due to any of the reasons, the quotations will be accept till 01:00 PM on the next working day.
- 3. The Technical Bids will be opened first and the Price Bid will be opened only after scrutiny of technical bid and technical evaluation of the DG Sets.
- 4. Only manufacturers, authorized dealer can participate in the quotation. This is subject to verification if necessary.

The quotation fee is non refundable. The NU Challan of Rs.1000/- as quotation form fee and 2% EMD should be attached with the Technical Bid.

- 5. In case the firm fails to attach the Challan of quotation form fee, the quotation shall be rejected straightway.
- 6. Incomplete quotation will not be accepted.
- 7. Conditional quotation will not be accepted.
- 8. The price must be quoted as per proforma price schedule Annexure "A". Nothing over and above the quoted price would be payable to the successful bidder. The bidder must quote the price both in words as well as in figures. Any over writing/cutting etc. render the quotation invalid.
- 9. Bidder would not be permitted to alter or modify their bids after expiry of the deadline for receipt of Bids.
- 10. If the supply is found inferior, the consignment will be rejected. The supplier will have to take back the consignment at his own cost and replace it with fresh stock as per approved samples within 15 days.
- 11. The committee, in order to satisfy itself can order on the spot enquiry to verify the soundness, capability, viability and any other information given by the tendering firms.
- 12. The Bid shall remain valid for six calendar months from the date of opening of the quotation.
- 13. The payment will be made after receipt/acceptance of goods in good condition. No advance payment will be made. Under no circumstances, sub-standard material will be accepted.
- 14. The Tender Committee reserves the right to relax any terms and condition in the interest of Nagaland University with the approval of Competent Authority.
- 15. The Tender committee reserves the right to reject any quotation or all quotation without assigning any reasons thereof.
- 16. The Competent Authority can terminate/recall the quotation due to administrative reasons.
- 17. All disputes are subject to the jurisdiction of the Courts at Nagaland.
- 18. A copy of terms and conditions duly signed & stamped by the tenderer, as a token of acceptance of the same should be attached along with the quotations.
- 19. Only TDS & GST payee agencies are eligible to submitted the quotation. Interested agencies must quote their GST No. in their quotation and also <u>attach</u> documentary proof of having registered with Tax Deptt. for sale of items etc. with technical bid.
- 20. The quotation will be rejected straightway without assigning any reasons if the firm declared black listed by any Govt./Semi govt. department/agencies etc.
- 21. Bidder(s) shall indicate complete technical specifications and all features of the quoted DG Set(s) and also <u>submit</u> its literature/brochures with the technical bid.
- 22. The tendering firm will also <u>submit a certificate</u> that the product offered by them is as per technical specifications of the quotation.
- 23. The bidder should carry an onsite **comprehensive warranty/guarantee** of DG Set(s) for a period of at least 12 (twelve) months.

- 24. If the performance of any individual equipment or System fails to meet the contract specifications then the same shall be replaced by the Supplier free of cost during the term of the warranty/guarantee period.
- 25. The maintenance services shall be **free of cost** during the warranty/ guarantee period.
- 26. During the term of warranty/guarantee the service/repair calls will have to be attended by the Supplier within forty eight hours from the time of such calls. The defective card/item/ equipment should be repaired the same day at Purchaser's location. In case of major defects requiring the defective card/item/equipment to be taken to the Supplier's workshop, it should be returned within a week duly repaired and an immediate substitute card/item/equipment will be provided by the Supplier for the smooth operation of the System. The to and fro transportation of the card/item/equipment will be the responsibility of Supplier.
- 27. Apart from the service/repair calls, the service engineer deputed by the Supplier will visit the site once in every 06 months to carry out the Preventive Maintenance and diagnostics of the system during the Warranty Period.
- 28. The bidder should <u>submit copy of certificates</u> regarding IS/ISI as indicated in the technical specifications [Annexure "B"] and attached with technical bid.
- 29. Successful bidder shall ensure backup for post warranty service requirements. Details for the same shall be furnished.
