- 9. The technical bid and the financial bid should be sealed by the bidder in separate envelopes duly super-scribed as "Technical Bid" and "Financial Bid". Both these envelopes are to be put in a bigger cover which should also be sealed and duly super-scribed "EOI for supply, installation, commissioning of equipment at I. - 10. Demonstration and training to the staff to be arranged by the firm free of cost on installation of the equipment.
- 11. The successful firm after qualifying for both technical and financial bid respectively shall have to furnish EMD/Security deposit @ 2% of estimated value of the goods.
