**NOTIFICATION**

In pursuance of the 36<sup>th</sup> Academic Council meeting Resolution No. AC:36:3:5, this is to notify that henceforth, BUGS and BPGS of all PG departments shall be merged into **Board of Studies (BoS)**.

The Powers and functions of the BoS shall be as given under OA7 and OA8 of the University Ordinance and the terms of office of members other than ex-officio shall be for a period of 3(three) years.

The composition of the **Board of Studies (BoS)** shall be as follows:

1.	Head of the Department	Chairman, Ex Officio	
2.	All Professors of the Department	Member	
3.	Two Associate Professors of the department by rotation on the basis of seniority	Member	
4.	Two Assistant Professors of the department by rotation on the basis of seniority	Member	
5.	One teacher each from other departments within the School having common/allied courses with the Department	Member	
6.	Not more than Two Teachers teaching allied/cognate subjects in other schools nominated by the Vice Chancellor on the recommendation of the Department Concerned	Member	
7.	Five Teachers from Affiliated colleges engaged in teaching the subject concerned nominated by the School Board	Member	
8.	Three External Experts in the rank of Professor nominated by the Vice Chancellor on recommendation of the School Board who have specialized knowledge in the discipline of the concerned department and who are not employees of the University or any of its affiliated or recognized Institutions	Member
