1. **AC:36:3:3:** Extension of PhD Registration Period beyond 6 years as per UGC (Minimum Standards & Procedures for Award of M.Phil./Ph.D. Degree) Regulations, 2016 shall regulated as follows-
 - i. Extension for Women Scholars beyond 6 (six) years shall be given up to 2 years as per the provision of the UGC (Minimum Standards & Procedures for Award of MPhil/PhD Degree) Regulations, 2016.
 - ii. Extension for Men Scholars beyond 6 (six) years shall be examined on case to case basis and such extension shall be given for 6 (six) month at a time up to a maximum of 1 (one) year.
2. **AC:26:8:10:** Time Frame for submission of PhD Thesis after Pre-submission Seminar.
 - i. The PhD thesis shall be submitted within 6 (six) month from the date of holding the Pre-submission Seminar failing which, the Pre-submission Seminar Report will be considered invalid
 - ii. There will be no wait period for submission of the PhD Thesis after holding of the Pre-submission Seminar. Accordingly, AC Resolution No. AC:16:7:24 stands amended.
