

**Terms and conditions for hiring of staff bus**

1. The vehicle to be provided must be in tip-top condition with minimum 52 seating capacity.
2. The vehicle must be available for 5 days in a week ( Monday to Friday).
3. All repair and maintenance, running cost, fuel lubricants, salaries of staffs, taxes etc. shall be borne by the contractor/agency.
4. In the event of repair, an alternative arrangement should be made by the contractor/agency to give uninterrupted service.
5. In the event of any accident, it will be the responsibility of the contractor/agency to deal with all accident related issues and bear all compensation there upon.
6. Driver and conductor should be technically/medically fit and should posses the proof of the same.
7. Contractor/agency will be responsible for good conduct of driver/conductor employed and if at any point of time the driver/conductor is found working unsatisfactorily, the said driver/ conductor shall be withdrawn and an alternate driver/conductor shall be provided.
8. All necessary documents should be available alongwith the vehicle during duty hours.
9. All staffs attached with the vehicle will be under the administrative control of University during duty hours.
10. The contract of hiring will be initially for a period of 2 years. The period may be further extended if found satisfactory. During holidays, hiring will be suspended and no charges shall be applicable.
11. The financial bid should be quoted on per day basis.
12. Monthly bills should be submitted in duplicate to the authority alongwith a photocopy of vehicle log book duly signed and certified by the controlling officer.
13. **Documents to be submitted for establishing bidders eligibility and qualifications**
  - (i) Proof of ownership of the vehicle.
  - (ii) Updated registration papers of the vehicle.
  - (iii) Updated vehicle insurance of the vehicle.
  - (iv) PUC (pollution under control) clearance, RTO clearance etc.
  - (v) Driver & conductor detail with medical fitness certificate.
