

Eligibility Criteria


1. Minimum Educational Qualifications, Experience, Publications Etc for the Post of **Various TEACHING POSTS** shall be applicable as prescribed by the UGC Regulations 2018/ NCTE Regulations 2014/ AICTE Regulations/ ICAR Guidelines (as the case may be) as amended from time to time.
2. The minimum required Research Publications shall be taken into account from the Peer-Reviewed or UGC listed Journals.

GENERAL INFORMATION/INSTRUCTION TO THE CANDIDATES

1.	Application fee for all the post is ₹1000/- (General/OBC/EWS Category) and ₹500/- (SC/ST). Application fees once paid shall not be refunded under any circumstances. The candidates from PWD category are exempted from payment of application fee.
2.	The period of time taken by candidates to acquire M. Phil and/or Ph.D Degree shall not be considered as teaching/ research experience to be claimed for appointment to the teaching positions.
3.	Candidates should upload scanned copies of their original certificates and mark-sheets from Matriculation onwards in support of their educational qualifications, experience etc.
4.	Qualifications, Experiences, age limit etc. As on last date of submission of applications will only be taken into consideration.
5.	No interim correspondence shall be entertained & canvassing in any form will be a disqualification.
6.	Separate applications Form and Fee are required for each post in case candidates intending to apply for more than one post.
7.	Persons who are already in service under State/ Central Government or any other organization should upload their scan copy of " NO OBJECTION CERTIFICATE " & " Vigilance clearance certificate ". However, those who are not able to upload has to submit the " NO OBJECTION CERTIFICATE " & " Vigilance clearance certificate " at the time of interview.
8.	The University shall have the right to restrict the number candidates for interview on the basis of qualifications and experience who posses higher than the minimum prescribed or by any other conditions as per the rules. The decision of the Screening Committee in regard to short listing the candidates from amongst the total number of applications received, shall be binding for all.
9.	Appointment made to the post against LIEN Vacancy are likely to be permanent subject to the condition that the lien is vacated. In case any lien holder reverts, the appointed candidate will be relieved.
10.	University shall verify the antecedents or documents submitted by candidates at any time during the process of recruitment/service. In case, it is detected that the documents submitted by the candidates are fake or the candidates has a clandestine antecedents/background for which he/she has been convicted by any court and has suppressed the said information, then his/her service shall be liable to be terminated.
11.	Submission of wrong/false information, if detected at any stage of the recruitment, the University reserves the right to withdraw/cancel any appointment made to the candidates.
12.	In case of any dispute/ambiguity that may occur in the process of Selection, the decision of the University shall be final and binding.
13.	A relaxation of 5% may be provided at the graduate and Masters level for the SC/ST/Differently-abled (physically and visually differently-abled)/Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic records for reserved category post during direct recruitment to teaching positions. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.
14.	Candidates claiming relaxation under reservation should submit a certificate of proof and clearly indicate in their application as "Reserved Category".

15.	Person suffering from not less than 40% of the relevant disability shall alone be eligible for the benefit of reservation for Person with Disabilities. They are required to submit the Disability Certificate issued to the candidate by the competent authority should be in the format prescribed by Government of India.
16.	Candidates applying against OBC Reserved post must submit valid (up to date) Non-Creamy Layer Certificate in the format for Appointment to the post under the Govt. of India. SC/ST Caste Certificate issued to the candidate by the competent authority should be in the format prescribed by Government of India.
17.	The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificates issued by the competent authority, as per the DoPT OM No.36039/1/2019-Estt. (Res.) dt.31.1.2019, as candidate's claim belonging to EWS. Candidate shall upload the copy of EWS certificate in the application form.
18.	The University reserves the right to increase/ decrease the number of posts and accept or reject application(s) without assigning any reasons. Further, the decision of the Screening Committee/Selection Committee/Executive Council shall be binding on all the candidates
19.	The Selection Committee may decide its own method of evaluating the performance of the Candidates.
20.	The rules of UGC/Govt. of India in regard to Pay and Allowances, Leave, Pension & Provident Fund shall be followed subject to amendments if any, from time to time. New entrants shall be covered by the National Pension Scheme (NPS)
21.	The selected candidates for appointment shall have to serve the University at least for a minimum period of 3 (three) years from the date of joining.
22.	Wherever the grading system is followed, equivalent percentage must be indicated in the relevant column of his/her application.
23.	All communication/call letter to the Candidates shall be sent through email only.
24.	Any Corrigendum/change/update related to the recruitment process shall be placed only on the official website of Nagaland University. www.nagalanduniversity.ac.in .
25.	Any dispute or legal proceedings against the University with regard to recruitment process, it will be resolved only under the jurisdiction of the Guahati High Court, Kohima Bench.
26.	Last date of submission of online application through CU CHAYAN portal is 05th April 2026 (Till 11:59 PM, IST)
