NOTIFICATION

In pursuance of Nagaland University Academic Council Resolution No. AC:43:19:1, the UGC (Mandatory Assessment and Accreditation of Higher Educational Institutions) Regulations, 2012, and Clause 3 of the Nagaland University Regulation for Granting of Permanent Affiliation (Non-Professional/Professional) 2021 and 2025, which stipulates that a college shall be accredited by NAAC or any other statutory accreditation agency of the State/Central Government, it is hereby notified that all Permanently Affiliated Colleges under Nagaland University which:

- (a) have not obtained NAAC accreditation or
- (b) whose NAAC accreditation validity has expired and has not secured subsequent accreditation/re-accreditation

shall take necessary steps to obtain accreditation/re-accreditation within a period of one year from the date of issue of this Notification.

Failure to comply with the above requirement within the stipulated period shall render the institution liable for review of its permanent affiliation status and such other action as may be deemed appropriate by the University under the Nagaland University Act, Statutes, Ordinances, Affiliation Regulations, Regulation on Institutional Governance and Academic Accountability in Affiliated Colleges, 2026 and other applicable UGC Regulations.
