DEFINITION OF FAMILY

FAMILY INCLUDES: -

- 1. Spouse residing with the Employee (Need not be dependent). Only one wife is included in the term Family.
- 2. Legitimate children and stepchildren, residing with and wholly dependent. Children include major sons, legally adopted children, and widowed daughters, residing with and wholly dependent.
- 3. Married daughter, if any divorced, abandoned, or separated from her Husband and residing with and financially dependent on the Parent.
- 4. Parents, stepmother, unmarried sisters, and minor brothers residing with and wholly dependent (Major Brothers are not included).
- 5. Widowed sisters residing with and wholly dependent (provided their Father is either not alive or is himself wholly dependent on the Employee).

EXPLANATION:

In the case of Wife/Husband, the necessary condition is 'residing with' the person need not be dependent on the Employee. Other Members of the Family should satisfy both conditions- 'residing with' and wholly dependent'

CHILDREN:

Studying in Educational Institution away from their Parents at the time of Transfer but joining their Parents at the time of vacation are treated as Members of Family subject to other conditions for Drawal of Travelling Allowances.

WARDS:

Children taken as Wards by the Government Servant under the 'Guardians and Wards Act, of 1890' will be treated as Government Servants' children if the Government Servant treats the Ward the same status as that of Natural Children.

SPOUSES INCLUDING:

Any Family Member whose Income from all sources does not exceed the amount of minimum family pension prescribed by the Central Govt (i.e. Rs.9000/-p.m.) and Dearness Relief thereon is deemed to be wholly dependent on the Govt servant.
