

FREQUENTLY ASKED QUESTIONS ON CURRICULUM AND CREDIT FRAMEWORK

(As part of FYUGP implementation by Nagaland University)

Are all the UG courses going to become four years programmes with the implementation of NEP FYUGP?

Under FYUGP, we will have Certificate (1 year), Diploma (2 years), Major (3 years), Hons and Hons with Research (4 years) programmes.

Respective colleges will decide about starting the 4th Year Hons. programme (after fulfilling the required criteria).

Is it compulsory for all the colleges to start the 4th year (Hons) programme?

Those colleges which are ready to introduce the 4th year programme, can go for the four-year UG programme.

When will University finalize the fourth-year syllabus?

The one-year PG programme course structure needs to be finalized first and after that fourth-year syllabus will be finalized.

When will Nagaland University have one-year P.G. programme?

That will be decided once NEP PG one-year structure is notified by UGC.

Will the existing major students under CBCS be able to shift to FYUGP?

Yes, the students can shift in the third semester and continue as they would have already earned 40 credits in the first two semesters, and also completed four core papers (from C1-C4). Thus, the students can continue from C5 paper onwards in the third semester.

Can the existing general students under CBCS shift to FYUGP Major programme?

Yes, a student can shift to third semester Major programme. However, the student needs to earn additional 4 credits from major courses, which can be done in the subsequent odd and even semesters. (Respective colleges may decide the Major subject).

Since a student needs to earn 60 credits in the Major Subject, additional requirements of 4 credits need to be earned to fulfil the criteria. While earning the additional 4 credits on Major subject in a particular semester, the student need not take the corresponding Minor course in that semester so as to maintain 20 credits for that semester.

What about the existing general students under CBCS who are not likely to shift to Major programme?

The Colleges have the option to continue at present with the CBCS system for those students who were admitted under CBCS system till the end of the programme.

Will there be no general courses under FYUGP?	Under FYUGP, a student can opt for B.A. or B.Sc. having minor subjects in A, B and C (A, B and C are three different subjects).
How can a student do double major?	A student needs to earn a minimum of 48 credits in the second major subject.
Since the Skill Enhancement courses are proposed from different subjects, do students need to take SEC from their respective subject?	University has provided a common pool of skill enhancement courses which have been proposed by different BUGS. The respective College can decide which SEC papers it is in a position to offer.
How will Internship be evaluated?	Internship will be evaluated internally as per the extant NU guidelines.
Since Nagaland state does not have any industry, how can students undertake internship?	NU guidelines allow doing internship beyond industrial training in accordance with UGC guidelines.
Can any college propose SEC and valued added courses?	Yes, colleges can propose that and it may be included subject to approval of university Academic Council.
Will 12 credits earned under Research project be part of Hons Credit?	Credit earned under Research project need not necessarily be part of Hons Credit. It is proposed as separate entity as per UGC guidelines.
What is the qualification required for admission into FYUGP?	Senior Secondary School Leaving Certificate or Higher Secondary (12 th Grade) Certificate obtained after successful completion of Grade 12 or equivalent stage of education corresponding to Level-4 (UGC Criteria of Eligibility).
